General Clinton Park and Payne Park Rules and Guidelines

Camping: Quiet time is daily from dusk to dawn. (Clinton Park Only)

Bicycles: Bike helmets must be always worn by children under 14; no exceptions. Helmets are recommended for all riders. No ATVs are allowed.

Trash: Dumpster provided for park use only. No household garbage is permitted.

Swimming: No swimming is permitted in any open waters connected to the park. Our town Swimming pool is available near Payne Park and has posted daily hours from June to September.

Firearms: Absolutely no firearms.

Fireworks: No fireworks are permitted.

Children: Parents are responsible for their children's actions and assume financial responsibility for damages or injury caused by them regardless of age. Children under 8 must be accompanied by a parent or Guardian to park bathrooms. Do not leave children under the age of 14 alone on the grounds.

Alcohol: No underage drinking or alcohol served to anyone under 21 years of age as per NYS Law. No drinking and driving. No illegal substances of any kind permitted anywhere on the park grounds. No person shall use or have in his or her possession any drug or narcotic; the sale, use or possession of which is prohibited by NYS state law.

Horses and Livestock: Horses and livestock are not permitted in the park unless it is an approved community sanctioned event. In the case of a community event, owners must clean up after and remove all animal feces from the park grounds. Horses and livestock are not permitted on the walking trails. (Clinton Park Only)

In an emergency, dial 9-1-1.

Littering and Pollution: Pollution of any waters is unlawful.

Dogs: All dogs must be always kept on a leash. This includes the walking trail. They must not pose a threat or disturb other park patrons. Owners are liable for any injuries or property damage caused by their dog. Owners are to clean up after their pet. All dogs must be licensed and be current on rabies. The park attendant and/ or the Bainbridge Dog Warden reserves the right to ask for this documentation at any time during your park visit.

Behavior/Park Damages/Vandalism: We reserve the right to ask any person to leave, without refund, for any reason. Examples include: Disrespect to other campers, excessive drinking, objectionable behavior or any violation of park rules. Any damages to any park property (buildings, grounds, monuments, trees, signs, pavilions, gazebo, benches, etc.) **will be deducted from your initial deposit**. Vandalism is never tolerated.

Speed limit: please adhere to all posted 5 MPH speed limit signs posted in the park.

Campfires: Campfires are only permitted in the fire rings. Do not leave fires unattended. Do not move fire ring or burn trash. The burning of plastic and Styrofoam is illegal as per NYS DEC laws. Due to New

York State regulations, firewood cannot be brought from outside of a 50-mile radius of the park. Do not cut trees or branches. Chainsaws are not allowed on campgrounds. (Clinton Park Only)
Protection of wildlife: Hunting of any kind is prohibited on the park grounds.
No Smoking : Smoking is prohibited in all buildings and park property. No smoking on park grounds, pavilions or playgrounds.
Please be respectful of other park patrons. The Town of Bainbridge will not be held liable for any accident or injury that may happen within park property. Use of the park is at the renter's risk
